- That the admission in the institution shall be made strictly in accordance with the norms as laid 3. down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste. creed or religion.

- That the Manager shall, within six months after the end of the every Academic year, submit to the 17. competent authority the report of Chartered Accountant on the Audit of the Accounts under subsection (1)
- That the concerned school will also not charge fee towards Building fund. Infrastructure fund and 18. development fund etc. from the students/parents.
